

TEXT PARTE Judge Casey L. Manning, Sr.

"Where you from," asks Fifth Circuit Court Judge L. Casey Manning, Sr., in his trademark radio announcer voice that belies his deep Dillon County roots. Whether you are a juror, lawyer, bailiff, or defendant you will get that question from Judge Manning--and he will more than likely know something about your hometown, no matter how obscure.

The fifth of six children born to factory workers who scrounged and saved to send each of their children to college, Judge Manning has a sarcastic wit that can be disarming to the unwary. A product of both segregated and integrated Dillon County schools, he applauds his teachers who opened up the world to him. He says he benefited from teachers who, back in the 1960s, taught the same subject for twenty years. A popular basketball player at the University of South Carolina in the late Sixties and early Seventies, Judge Manning was coached by the legendary Frank McGuire.


His parents expected him to focus on his studies and stay out of trouble. Even though he was socially aware during this tumultuous period, he avoided trouble. When there were protests during his USC years, his friends wanted to check them out-but Judge Manning wisely elected to stay in his dorm. Years later, he notes that most defendants in criminal cases would benefit from the same maxim-avoid people and places where disturbances erupt.

On the bench for sixteen years, Judge Manning voices concern about the percentage of Americans who are incarcerated. According to *The New York Times*, the United States has less than five percent of the world's population, but nearly a quarter of the world's prisoners. America has the highest documented incarceration rate, with one in a hundred adult Americans in prison or jail. Judge Manning philosophically disagrees with some mandatory minimum sentences as the harsh sentences don't always fit the facts of the case. Each case is different, he notes, and sometimes the government is lucky to get a plea at all.

He calls the legislative screening that led to Judge Kenneth Goode's recent retirement the "most fundamentally disturbing" occurrence he has seen since he has been on the bench. Judge Goode's controversial sentence of a daycare worker to a ten-year suspended sentence and probation for the offense of causing "great bodily injury to a child" caused an outcry by the victim's family and some legislators. In his

rapid cadence, Judge Manning laments that Judge Goode lost his job even though he did nothing wrong. He warns new judges of the consequences of unpopular decisions and notes the chilling effect of the inquiry.

He notes the next time he will go before a screening committee will be at the Pearly Gates. If there is any doubt that he does not



care about ingratiating legislators at this point in his career, you can just look at the legislative manuals for the last few years on his bookshelf. They are still in their original plastic wrappers.

His advice to lawyers is to pay attention to detail. He gets frustrated by lawyers who don't know the maximum sentence for the charge to which their client is pleading. Know about your client and "paint a picture" for the judge. He uses Abraham's plea on behalf of the city of Sodom as the best illustration of an argument. On the civil side, he advises if you are going to argue a Rule 59(e) motion, at least "have the damn rule in front of you."

Like his parents before him, he has instilled the value of education in his three children, Charlotte, Casey, Jr., and Morgan. The older two graduated from prestigious universities and operate in the dot-com world. His youngest daughter, Morgan, is a student at the University of California at Riverside.

For every day of his sixteen years on the bench, his administrative assistant, Mrs. Ada James, has been his right hand. He describes her as the "most wonderful woman in the world." When he retires in a few years, the bench will lose one of its most colorful characters and most intellectual jurists.

PROJECT H.E.L.P. UPDATES

Project H.E.L.P (Homeless Experience Legal Protection) is preparing to celebrate one year of success in assisting Columbia area homeless people with their legal needs. More than 50 attorneys have volunteered their time and expertise at the clinic to assist about 50 clients since November 2008, when the Richland County Bar, the Public Service Committee, and community sponsors launched the project. Project H.E.L.P's host for its first year has been St. Lawrence Place, a transitional housing facility for working homeless families in Columbia. With a year of knowledge and experience, and outstanding assistance from the St. Lawrence Place staff, Project H.E.L.P. is preparing to move to a new location and broaden its client base.

Some exciting changes are in the works. Beginning in November, Project H.E.L.P. will be hosted by Catholic Charities of the Midlands, on the corner of Assembly and Taylor Street. This new central location downtown will make the clinic more accessible to clients with limited transportation. In the past year Project H.E.L.P. has also developed relationships with more Midlands area organizations providing assistance to the homeless and is reaching out to those groups to identify clients who are in need of the clinic's resources.

Ideally, the clinic will be staffed with five or six volunteers who will donate about two hours of their time on the third Thursday of the month. The goal for 2009 is to serve between 12 and 15 clients each month. Clients will continue to make appointments to meet with an attorney volunteer so that we can identify their legal need in advance and give the volunteers a bit of time to prepare to assist the clients.

Another exciting expansion comes in the form of certifying and retaining copies of identification documents for clients. Homeless individuals often have a difficult time keeping their driver's licenses, social security cards, and other government issued identification. This identification is required to use many services, including staying in some shelters. It can often take six weeks or more to replace lost or stolen identification. Catholic Charities has graciously offered to maintain a file of certified copies of H.E.L.P. clients' identification to be used in case those items are lost and need to be replaced. Volunteers will be needed to notarize these copies. This is a great opportunity for judges and judicial clerks, paralegals, and law students to give much-needed assistance to Project H.E.L.P. clients without giving any legal advice. Also, if you have a locking file cabinet that you would like to donate for the project, please let us know.

Project H.E.L.P. was started by Judge Jay Zainey, U.S. District Judge for the Eastern District of Louisiana. Judge Zainey started Project H.E.L.P. in New Orleans to assist homeless people with maintaining certified copies of identification documents so that they would be available for service providers. Since Hurricane Katrina's tremendous impact on the needs of New Orleans residents, the project has grown dramatically and expanded to other cities including New York, Chicago, Baton Rouge, Lafayette, Shreveport, Birmingham, Savannah, as well as Columbia.

In Columbia, the RCBA H.E.L.P. project operates a once-monthly morning clinic offering pro bono legal services and providing basic information about access to government benefits, identification documentation, housing, child custody, and other common legal issues affecting the homeless. Community programs serving the homeless help the clinic identify clients by encouraging individuals with legal needs to participate.

Morning legal clinics will be held every third Thursday of the month. Upcoming clinic dates are October 15th, November 19th, and December 17th. To learn more or to volunteer, please contact Kristen Horne at kristen.horne@nelsonmullins.com.

Mediators, Arbitrators, and Special Referees
